Annual Summary

Description: This composite includes all discretionary extended duration fixed income accounts measured against the Bloomberg Barclays Capital U.S. Treasury Strips 20+ Index, which was administered and supplied by Lehman Brothers prior to 11/3/08. The composite may be compared to other appropriate indices, as requested. BHMS utilizes a bottom-up security selection process, based on fundamental research, which seeks to achieve returns that are superior to the returns of its benchmarks over complete market cycles, with lower volatility of return.

- BHMS is an investment advisor registered with the SEC. BHMS is a subsidiary of OM Asset Management plc ("OMAM"), a publicly-held company traded on the New York Stock Exchange. - The composite was created on October 1, 2007. The composite inception date is October 1, 2007.
- Performance is expressed in U.S. Currency. The returns include the reinvestment of all income. Gross-of-fees performance results are presented before investment management fees and custodial fees. Net-of-fees performance returns are calculated by deducting the actual fees from the accounts. The assets in the BHMS Extended Duration Composite have included assets seeded by our parent company, Old Mutual, prior to June 2011. Fees on the assets seeded by Old Mutual are waived. BHMS Extended Duration Fixed Income Fee Schedule: 0.25% on the first \$20 million, and 0.15% on assets over \$20 million. Actual investment advisory fees incurred by clients may vary.
- Dispersion of annual returns is calculated for the accounts in the composite for the entire year by an asset-weighted standard deviation calculation method. Where composite dispersion is N.A., the information is not statistically meaningful due to an insufficient number of portfolios for the entire year.
- BHMS has added portfolio managers and analysts to support and enhance its research capabilities and asset growth. However, no alterations of composites, as presented herein, have occurred due to changes in personnel. Past performance is not indicative of future results.
